

## Consent to the processing of User's personal data

The user (personal data subject) carrying out any interaction with the website https://www.tehnodent.org/en/ (hereinafter referred to as the website), accepts this Agreement for the processing of personal data (hereinafter referred to as the Agreement).

The User (personal data subject), acting freely and confirming their legal capacity, gives their consent for processing of personal data to TehnoDent Limited Liability Company (TehnoDent LLC, OGRN 1103123015434 INN 3123223010, 1/6 Berezovaya st., Severny urban settlement, Belgorodsky district, Belgorod region, 308570) subject to the following conditions:

- 1. This Consent is given to the processing of the following personal data of the User (personal data subject):
- Surname, name, patronymic, gender, age, postal and e-mail addresses, phone numbers of the User (personal data subject);
- System information, browser data of the User (personal data subject);
- Cookie files of the User (personal data subject);
- IP addresses of the User (personal data subject);
- Information about the operating systems installed on the devices and the types of browsers of the User (personal data subject);
- Information about the extensions installed on the devices and the screen colour settings of the User (personal data subject);
- Information about the languages installed and used on the devices of the User (personal data subject);
- Flash versions and JavaScript support;
- Information about the types of mobile devices used by the User (personal data subject);
- Geographical location of the User (personal data subject);
- The number of visits to the website and page views by the User (personal data subject);
- The duration of the User's (personal data subject's) viewing of the website;
- The User's (personal data subject's) queries, including those made by the User (personal data subject) when opening the website;
- Pages from which the User (personal data subject) transferred.
- 2. Personal data shall not be publicly available.
- 3. The purpose of processing personal data: processing incoming requests from individuals, including those representing the interests of legal entities; analysing the actions of individuals on the website; distributing newsletters (if the User subscribes to them);
- 4. During the processing of personal data, the following actions will be performed: collection, recording, systematization, accumulation, storage, clarification (updating, modification); extraction, use (for the purposes specified in clause 3), deletion, destruction.
- 5. The processing of personal data may be terminated at the request of the User (personal data subject). Consent may be revoked by the User (personal data subject) or their authorized representative by notifying TehnoDent LLC, OGRN 1103123015434 INN 3123223010, 1/6 Berezovaya st., Severny urban settlement, Belgorodsky district, Belgorod region, 308570, or its representative, in writing to the following email address: info@tehnodent.org.
- 6. If the User (personal data subject) or their representative revokes this Consent, TehnoDent LLC shall be entitled to continue processing their personal data only on the basis of the current laws of the Russian Federation.
- 7. This Agreement shall be valid for an indefinite period until the purposes of processing are achieved or until it is revoked.
- 8. I have been informed about the ability to refuse the processing of my personal data contained in cookie files by stopping the use of the site or disabling cookies in the browser settings.
